

Dimitar Bechev is Adjunct Professor at the University of Sofia where he teaches European Studies and International Relations. He is also affiliated with the European Institute at the London School of Economics and Political Science. United Kingdom. Previously, he headed the Sofia office of the European Council on Foreign Relations, where he had been a Senior Policy Fellow. Bechev has written extensively on the politics and history of modern Turkey and the Balkans, EU external affairs and Russian foreign policy. He is a frequent contributor to Al Jazeera, CNN, Foreign Policy and openDe-Bechev received mocracy. his D.Phil. in International Relations from Oxford University in 2005.

At CES, Bechev will investigate how Russia's foreign policy and the EU's enlargement policy are impacting the energy sector in Southeast Europe, specifically Bulgaria, Croatia, Cyprus, Greece and Romania.



Michelle Bentley Dr. is Reader in International Relations and Director of the Centre of International Public Policy (CIPP). Her research has been published in prominent journals, including Security Studies, Review of International Studies, and International Affairs. She has written two sole-authored books: one analysing WMD and the strategic use of concepts, and a second entitled Syria and the Chemical Weapons Taboo: Exploiting the Forbidden, looking at US foreign policy on the Syrian crisis. She has also published two edited volumes on the Obama administration and continuity in US foreign policy. She has also published on higher education issues and was awarded the 2017 POLITICS Learning and Teaching Prize for her research on trigger warnings.



Dr. Evgeny Kozhokin was born in 1954 in Moscow. In 1977 he graduated from Moscow University faculty of history. He received his Candidate of Science degree in history in 1977 and Doctor of Science in 2000. In 1980-1984 Evgeny Kozhokin worked as assistant researcher at the Institute of International Labor Movement and in 1984-1990 as research fellow at the Institute of World History of the Soviet Academy of Sciences. In 1990 he was elected People's Deputy of the Russian Federation and became Chairman of the Subcommittee of International Committee Relations of the of

International Relations and Foreign Economic Relations at the Supreme Soviet of the Russian Federation. In 1991 he headed the group of Russian observers in Nagorny Karabakh.

In 1992-1993 Dr Kozhokin was elected Chairman of the Subcommittee of International Security of the Defense and Security Committee at the Supreme Soviet of the Russian Federation. In 1993-1994 he worked as Deputy Chairman of the State Committee on Nationality Affairs. In 1994-2009 he was Director of the Russian Institute of Strategic Studies, in 2009-2010 – Deputy Head of the Federal Agency for the Commonwealth of Independent States, Compatriots Living Abroad, and International Humanitarian Cooperation. In 2010-2014 Dr. Kozhokin worked as President of the Academy of Labor and Social Relations. In 2014 he was appointed professor and in 2015 – Vice President for Research at MGIMO University.

Dr. Kozhokin participated in numerous negotiations as the head or a member of Russian delegation. He authored more than 120 academic publications on history of Russia and Western Europe, conflict resolution, economic and political cooperation between Russia, Western Europe and CIS countries which appeared in Russian, English, French, Chinese, Spanish, German, Bulgarian and other languages. He taught at several Russian universities including Moscow University, MGIMO University and Academy of Labor and Social Relations.



Tomáš Kučera is an assistant professor at the Department of Security Studies, Charles University in Prague. He received a doctorate at Aberystwyth University for a thesis examining the relationship between liberal ideology and defence policies in Western Europe, in Germany and the United Kingdom in particular. Societal-military relations, military ethics and sociology of security and defence continues to present his main research interests. His publications appeared, e.g. in the journals Armed Forces & Society, Geman Politics, and Journal of Military Ethics. His book The Military and Liberal Society was published with Routledge in 2017. His teaching focuses on war studies, civil-military relations and ethics of war.

Dr. Guillaume Lasconjarias is the defense education advisor to the French Ministers of Education and Superior Education. Prior to this, he was a researcher in the Research Division of the NATO Defense College in Rome. A military historian by trade, his areas of interest include military doctrine, revolution in military affairs, professional military education and the concept of hybrid war. He has held a number of different positions within the French Ministry of Defense. He was a researcher at IRSEM - Institute for Strategic Research - from 2010 to 2012.

In this capacity he lectured on various topics at the French École de Guerre, where he was also in charge of an elective course. From 2007 to 2010, he served as Deputy to the Head of the Research Bureau at the French Army Centre for Force Employment Doctrine. He started his professional career as a university lecturer at the Sorbonne in Paris.

Guillaume Lasconjarias is also a reserve officer, having graduated from the ROTC in Saint-Cyr Coëtquidan. He has been deployed on various exercises and operations. He currently serves as a staff officer in charge of academic operations at the French Army War College.

He holds a PhD in History from the Sorbonne. An alumnus of the École Normale Supérieure in Lyon, he has published three books and several articles in English, French, and Italian defense publications. She is the author of The Politics of Becoming European: A Study of Polish and Baltic Post-Cold War Security Imaginaries (Routledge, 2010) and a co-author of Remembering Katyn (Polity, 2012). Her work on European security politics, transitional justice, liminality,

memory wars and memory laws has appeared in leading international studies journals and various edited volumes, most recently in International Studies Review and European Security. Before joining BSIS, Dr Mälksoo worked as Senior Researcher in International Relations at the University of Tartu in her native Estonia. She has held post-doctoral research fellowships at the Centre for International Studies, London School of Economics and Political Science, Helsinki Collegium for Advanced Studies, and the University of Tartu. Dr Mälksoo has policy experience from the Estonian Ministry of Defence, International Centre for Defence Studies in Tallinn, and the Office of the President of Estonia. She is a member of the editorial boards of Journal of Genocide Research, Contemporary Security Policy, International Political Anthropology and New Perspectives, and currently serves at the CEEISA Executive Committee and the EISA Governing Board.



Dr. Matúš Halás is the Head of the Centre for European Security at the Institute of International Relations in Prague. He previously worked in professional military education, as a lecturer in strategic studies at the Baltic Defence College in Tartu (Estonia) and before that as an assistant professor at the Institute of European Studies and Interna-Relations in Bratislava tional (Slovakia). His research focuses adaptation of deterrence on theory to modern warfare and hybrid threats. His articles appeared, for example, in Geopolitics, Europe-Asia Studies or Cambridge Review of International Affairs. He also regularly writes op-ed articles on topics related to international politics for Slovak newspapers.

Hanns W. Maull held the Chair for Foreign Policy and International Relations at the University of Trier in Germany until March 2013; since then, he has been associated as Senior Fellow Distinguished with the German Institute for International and Security Affairs of the Foundation for Science and Policy (SWP), Germany's foremost foreign policy think tank, as well as (since January 2016) with the Mercator Institute for China Studies (MERICS) as Senior Policy Fellow on China and World Order.

Hanns Maull continues to teach as Adjunct Professor of International Relations at the John Hopkins School of Advanced International Studies' Bologna Center. Educated in Munich and London, his previous positions include positions at the International Institute for Strategic Studies (IISS) in London, professorial positions at the at the Universities of Munich, Eichstätt and Trier and a three-years spell as the European Secretary (now European Director) of the Trilateral Commission.

Prof. Maull has published more than a dozen monographs, edited a number of books, and contributed widely to journals in German, English, French, Italian, and Japanese, including Foreign Affairs, International Affairs, Politique Etrangère and Chuo Koron. He has contributed OpEds, among others, to the International Herald Tribune, Die ZEIT and the Frankfurter Allgemeine Zeitung. His most recent work is an edited volume, "The Rise and Decline of the Post-Cold War International Order", published by Oxford University Press in 2018. In 2017, he was rewarded the Order of the Rising Sun with Gold Rays by the Japanese Emperor.



Dr. Harald Müller has been Executive Director of Peace Research Institute Frankfurt (1996-2015) and served as Professor of International Relations at Goethe University Frankfurt (1999-2015). Before, he taught as associate professor at the Technical University Darmstadt. He was guest professor at John Hopkins University Center of Interntional Studies, Bologna, at Potsdam University, Germany, at Sciences Politiques, Paris, and at Hebrew University, Jerusalem.

Dr. Müller was very active in political consultation and advice. He served on the German Delegation to Review Conferences of the parties to the Nuclear Non-proliferation Treaty (1995-2015), on the UN Secretary General's Advisory Board for Disarmament Matters (1999-2005), on the IAEA Expert Group on Multinational Nuclear Arrangements (2004/5), and as Vice President of the EU Consortium on Disarmament and Non-proliferation (2011-2016). He was a member of the Commission on Security and the Future of the Armed Forces of the German Federal Government (1999/2000), Co-Chairman of the Advisory Council on Peace and Conflict, German Foreign Office (1999-2015) and Member of the Advisory Council of the German Federal Academy for Security Policy (2000-2008).

After his retirement in 2016, Dr. Müller has been working as Senior Associate at Peace Research Institute Frankfurt. He became Senior Associate and Supervisor of the Peace Research Center Prague in 2018. He is also a member of the Working Group on Arms Control and Disarmament of the German Foreign Office.



Dr. Tomasz Paszewski is a Research Fellow at the Institute of Political Studies of the Polish Academy of Sciences. He previously worked for the Center for Inter-Relations, national Warа independent saw-based think tank. He holds an MA in International Relations from Warsaw University, and PhD from the Institute of Political Studies. Gabriela Boiteux Pilná is Head of Unit for Multilateral Development Cooperation, in the Department for Development Cooperation and Humanitarian Aid of the Czech Ministry of Foreign Affairs since August 2016. Before that, she worked for four years at the Czech Permanent Representation to the European Union in Brussels and represented the Czech Republic in the Working Party on Development Cooperation (CODEV) and the Working Party on the Humanitarian Aid and Food Aid (COHAFA). Between 2009 and 2012, she served as Deputy Head of Mission at the Embassy of the Czech Republic to Algeria where she was also responsible for the relations of the Czech Republic with Mali. She worked as humanitarian aid desk officer at the Ministry of Foreign Affairs from 2008 to 2009. During the Czech Presidency of the Council of the EU, she served as Deputy Chair of the Working Party on Humanitarian Aid and Food Aid. Gabriela Boiteux Pilna studied International Relations at the University of Economics in Prague and Economic and Social Administration at the University of Palacky in Olomouc. She graduated from Ecole Nationale d'Administration (ENA) in Strasbourg.



Ondrej Rojcik is a Head of Strategic Information and Analysis Unit at the National Cyber and Information Security Agency of the Czech Republic. He is responsible for strategic cyber threat analysis, horizon scanning and strategic early warning. He has over twelve years of experianalyzing international ence security issues including for the Ministry of the Interior of the Czech Republic and for NATO. Ondrej holds MSc in Security Studies from University College London and PhD in International Relations from Masaryk University in Brno, the Czech Republic.



Dr. Sabine Selchow is a Research Fellow in the ARC-Laureate Program in International History at the University of Sydney, where she is in charge of the 'Planetary Pasts and Futures'-research theme. She is also Research Associate at the Conflict and Civil Society Research Unit at the London School of Economics (LSE) and Visiting Senior Research Associate at the Institute for Global Prosperity, University College London (UCL).

Dr Selchow's research explores how modern institutions and principles, in general, and the nation-state, in particular, are reinvented in the face of global and planetary challenges, with a particular interest n security practices

and discourses and the role that global civil society plays. She is the author of Negotiations of the 'New World': The Omnipresence of Global as a Political Phenomenon(transcript, 2017), which explores what social and political actors do when they use the adjective 'global', and the co-editor of Global Civil Society 2012: Ten Years of Critical Reflection (Palgrave, 2012, with M Kaldor and H Moore), Subterranean Politics in Europe (Palgrave, 2015, with M Kaldor) and EU Global Strategy and Human Security: Rethinking Approaches to Conflict (Routledge, 2018, with M Kaldor and I Rangelov).

Before joining Sydney University in November 2017, Dr Selchow spent over a decade at the LSE. Until 2017, she was Research Fellow in the ERC-funded research programme 'Security in Transition' (directed by Mary Kaldor), based at LSE's Civil Society and Human Security Research Unit. In the 'Security in Transition'-programme, she led the 'Culture/s'-research component. From 2013 to 2016, she was also a Research Fellow in Ulrich Beck's ERC-funded project 'Methodological Cosmopolitanism: In the Laboratory of Climate Change' at Ludwig-Maximillians-Universität Munich.

Dr Selchow studied North American Studies and Communications Studies at Freie Universität Berlin (Germany) and then at Duke University (USA). She holds a PhD in Government from the LSE (UK).



Dr. Michal Smetana is Research Associate and Assistant Professor at the Faculty of Social Sciences, Charles University, and Coordinator of the newly-established Peace Research Center Prague. His main research interests include nuclear politics, arms control and disarmament, proliferation of weapons of destruction. deterrence mass theory, norms and deviance in international affairs, frozen conflicts, and political psychology. His most recent articles have been published in International Affairs, The Washington Quarterly, Journal of International Relations and Development, Asia Europe Journal, Bulletin of the Atomic Scientists, The Nonproliferation Review, and other academic and policy journals. He is the co-author of Global Nuclear Disarmament: Strategic, Political, and Regional Perspectives (Routledge) and Indirect Coercion: Triangular Strategies and International Conflict (Charles University Press).
